6. On-Farm Water Conservation Program

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

7. License Agreement for Canal Encroachment

PG&E wishes to connect to an existing power pole on the southerly right-of-way of the Main Canal, just west of Center Avenue in Los Banos, to provide power to an AT&T cellular telephone facility on the adjacent property. The Board will be asked to approve a license agreement to allow the connection to the existing power pole, and to authorize the President and Secretary to execute the agreement on behalf of the District.

8. Presentation of 2014 Financial Report

John M. Murao, the District's independent auditor, will present the 2014 audited financial report. The Board may accept the report as presented, or may take it under advisement for consideration and acceptance at the next Board meeting.
