**2. Review of Agenda**

The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

**5. Public Participation**

At this time, members of the public may address the Board on matters that are not on the agenda, which affect the operations of the District and are within the jurisdiction of the Board. The President may limit the time allowed for comment. (Members of the public may also address the Board on any matter on the agenda, when that item is brought up.)

**6. On-Farm Water Conservation Program**

A number of conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

## **7. Alternative Energy Sources**

### **a. Solar Power**

Based on initial meetings and investigation work, staff has determined that the installation of one or more solar power facilities could be beneficial to the District. A report of the initial findings will be presented and the Board will be asked to give staff direction as to whether and how to proceed.

### **b. Hydro Power Plants**

The Board will be updated as to the status of the two existing small hydro plants west of Los Banos, and may be asked to give direction to staff.

## **9. Monthly Financial Report**

The Secretary will present figures through June 30 for water sales, revenues and expenses in comparison to the 2015 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected to be taken.

## **10. License Agreement – PG&E Overhead Electrical Line**

PG&E wishes to construct an overhead electrical line across the Sullivan Extension Canal, west of Gustine, in order to serve a new well on property owned by Mike Sandu. Staff and General Counsel have determined that the proposal meets CCID's engineering and legal requirements, and the Board will be asked to approve a license agreement and authorize the President and Secretary to execute the document on behalf of the District.

## **11. Legal and Four-Entities Matters**

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.

## **12. Miscellaneous Business**

At this time, Board members and staff may discuss matters that are not on the agenda which may affect operations of the District. No Board action is expected to be taken.
