2. Review of Agenda

4. Water Report and Informational Items

5. Public Participation

At this time, members of the public may address the Board on matters that are not on the agenda, which affect the operations of the District and are within the jurisdiction of the Board. The President may limit the time allowed for comment. (Members of the public may also address the Board on any matter on the agenda, when that item is brought up.)

6. On-Farm Water Conservation Program

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

7. 2016 Water Supply

The Manager will update the Board on the 2016 water supply situation. Board action may be requested with regard to water allocations, availability of water for Class 2 lands, and potential supplemental pool program(s).

8. Well Pumping Policies

The Board will be asked to review the District's well water pumping policies, including pumping of private wells for transfer to Federal districts, and may consider revisions to the policies for 2016.

9. Legal and Four-Entities Matters

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.

10. Miscellaneous Business

At this time, Board members and staff may discuss matters that are not on the agenda which may affect operations of the District. No Board action is expected to be taken.
