**2. Review of Agenda**

The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

**5. Public Participation**

At this time, members of the public may address the Board on matters that are not on the agenda, which affect the operations of the District and are within the jurisdiction of the Board. The President may limit the time allowed for comment. (Members of the public may also address the Board on any matter on the agenda, when that item is brought up.)

**6. On-Farm Water Conservation Program**

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

**7. Pumping of Private Wells for Water Credits in Federal Districts in 2015**

The Board will be asked to review and approve requests from one or more CCID landowners who wish to pump private wells for water credits for their own properties in neighboring Federal districts in 2015.

**8. License Agreement for Canal Encroachment**

PG&E wishes to connect to an existing power pole on the southerly right-of-way of the Main Canal, just west of Center Avenue in Los Banos, to provide power to an AT&T cellular telephone facility on the adjacent property. The Board will be asked to approve a license agreement to allow the connection to the existing power pole, and to authorize the President and Secretary to execute the agreement on behalf of the District.

**10. Monthly Financial Report**

The Secretary will present figures through April 30 for water sales, revenues and expenses in comparison to the 2015 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected to be taken.

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.
