The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

5. Public Participation

At this time, members of the public may address the Board on matters that are not on the agenda, which affect the operations of the District and are within the jurisdiction of the Board. The President may limit the time allowed for comment. (Members of the public may also address the Board on any matter on the agenda, when it is brought up.)

6. On-Farm Water Conservation Projects

It is expected that one or more on-farm conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be ready to present for final approval and funding. The Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the President and Secretary to execute loan documents on behalf of the District.

7. Interim Report on Written History of CCID

Local historian Alan Paterson will give the Board an interim report on his progress to date on producing a written history of the District. No action is expected to be taken by the Board.

8. Long-Term Easement Agreement for East Ditch Reservoir

The Board will be asked to adopt Resolution No. 14-12 to accept the terms as negotiated and to authorize the President and Secretary to execute a 30-year Grant of Easement agreement for 24.47 acres of ground owned by William Paul Hunger, which will be used by the District for the East Ditch Reservoir, a component of CCID's conservation program.

9. License Agreement – PG&E Underground Gas Pipeline

PG&E wishes to install a 12-inch gas pipeline beneath the Outside Canal along the northerly edge of the right-of-way of the San Luis Wasteway, in the Santa Nella area. The proposal meets CCID's engineering and legal requirements, and the Board will be asked to approve a license agreement, and to authorize the President and Secretary to execute the document on behalf of the District.

11. Monthly Financial Report

The Secretary will present figures through May 31 for revenues and expenses in comparison to the 2014 budget, receivables, investments, and the reserve funds for water conservation loans and projects. No Board action is expected to be taken.
